3. Attached hereto as Exhibit "A" is a true and correct copy of my resume.

B. My Involvement in this Matter

4. In April 2014, I began working with Andrew Levetown of Levetown & Jenkins, LLP, investigating the facts regarding AdSense publisher withholdings. Mikki Barry (also of counsel to Levetown & Jenkins) and I originally received a complaint from an Adsense partner who had been terminated in 2012. At Mr. Levetown's direction, I contacted this entity and its principal in April 2014 to obtain the facts about this termination. I interviewed him and reviewed documentation. I also worked with Ms. Barry and Mr. Levetown to obtain corporate information about this prospective plaintiff and ownership information about the entity involved. In addition to performing this work, I performed legal research and factual research regarding Google AdSense terminations to determine whether our original complainant's facts were common and typical of others and to determine whether others were similarly situated. I also interviewed witnesses and other publishers regarding their terminations and the reasons given by Google.
